Sausage & Cider Festival Raceday Competition Series - Terms and Conditions

- 1. In order to enter a Sausage & Cider Festival Raceday Competition (the "Competition"), organised by Arena Leisure Racing Limited (the "Promoter") you must have a valid entry to attend one of the following racedays (each a "Competition Date") on the following racecourses (each a "Racecourse"):
 - a. 29 March 2025 Uttoxeter Racecourse;
 - b. 26 April 2025 Doncaster Racecourse;
 - c. 26 April 2025 Wolverhampton Racecourse;
 - d. 2 June 2025 Royal Windsor Racecourse;
 - e. 13 July 2025 Southwell Racecourse;
 - f. 16 July 2025 Ffos Las Racecourse;
 - g. 17 July 2025 Worcester Racecourse.
- 2. The Promoter shall advertise and promote the Competition on the Competition Dates at the Racecourses. Upon entry on a Racecourse on a Competition Date, the entrants shall register to partake in the Competition by going to the Racecourse office and fill out the registration form handed out by Racecourse staff with name and telephone number.
- 3. Entrants must be resident in the UK aged 18 or over.
- The entrants may only submit one entry per Racecourse. Provided they do not win the Competition at a Racecourse, they may register to partake in the Competition at the other Racecourses.
- 5. Entries must not be submitted through agents or third parties, and any such entries will be invalid.
- 6. The entries must be submitted before the first race of the day starts.
- 7. The Competition shall take place on a stage after the third race of the day at the location disclosed by the Promoter in a clear manner on the PA system and screens at the Racecourse.
- 8. Eight participants shall be chosen at random by the Promoter to participate in each Competition. The Promoter's decision is final, and no correspondence will be entered into. The entrants will be informed they were selected by the Racecourse staff via the telephone number they provided on the registration form. The selected entrants must go the stage where the Competition is taking place with proof of ID no less than 10 minutes prior to the Competition. Failure to present themselves on the stage within this period shall lead to the entry being forfeited and entitles the Promoter to redraw another participant without liability.
- 9. The entrants may only participate on the Competition if they provide to the Promoter's staff at the Racecourse a signed copy of the disclaimer form (the "Disclaimer Form") provided by the Promoter prior to the Competition. A copy of the Disclaimer Form is hereby attached to these Terms and Conditions for information purposes.

- 10. The entrants win the Competition by being the fastest at eating all the food provided by the Promoter, which shall include a foot long pork sausage, including roll. At the entrants' request, sauces may be provided by the Promoter. Each entrant shall have water, and a sick bucket made available at the time of the Competition taking place.
- 11. The entrant who wins each Competition shall qualify for the final which shall take place at Bath Racecourse on 13 September 2025 (the "Final"). The winner of each Competition shall also be awarded the following:
 - a. a trophy;
 - b. a table for two at the Racecourse where they participated in the Competition's restaurant, including a food and drinks package selected by the Racecourse;
 - c. eleven free tickets for the Final;
 - d. one drinks vouchers per ticket for the Final;
 - e. one food voucher per ticket for the Final; and
 - f. one racecard per ticket for the Final.
- 12. The remaining seven participants on each Competition Date shall be entitled to two free tickets for another raceday at the Sausage & Cider Festival Raceday in 2026 at the Racecourse where they participated in the Competition.
- 13. To compete in the Final, the entrants who qualify to it as per paragraph 11 shall attend the Final's Competition Date and participate on the Competition as per paragraph 10's rules.
- 14. The winner of the Final shall be entitled to the following:
 - a. a trophy;
 - b. one annual membership for two at the Racecourse where they participated in the Competition; and
 - c. a table for ten at the Sausage & Cider Festival Raceday in 2026 at the Racecourse where they participated in the Competition.
- 15. The remaining participants of the Final shall receive a Sausage & Cider hamper basket and two free tickets to a raceday taking place at any of the Promoter's racecourses, which shall include: Bath, Brighton, Chepstow, Doncaster, Ffos Las, Fontwell Park, Great Yarmouth, Hereford, Lingfield Park, Newcastle, Royal Windsor, Sedgefield, Southwell, Uttoxeter, Wolverhampton and Worcester Racecourses.
- 16. The Promoter shall get in touch with the winners and participants of the Competition who are entitled to prizes as per the above to claim their prizes.
- 17. The prizes are non-exchangeable, non-transferable, non-endorsable and not redeemable for cash or other prizes. The Promoter retains the right to substitute a prize or part of it with another prize of similar value in the event the original prize offered is not available.
- 18. The Promoter reserves the right to use the name of the winner and the remaining participants for the purpose of publicity without charge, and the winner and the remaining participants hereby consent to the same.

- 19. Events may occur that render the Competition itself or awarding the prizes impossible due to reasons beyond the control of the Promoter and the entrants agree that no liability shall be attached to the Promoter as a result thereof. The Promoter reserves the right to offer an alternative prize of equal value should this prove necessary.
- 20. The Promoter is not sponsored, endorsed or administered or associated with any social media used, and such social media does not endorse the products of the Promoter. No information relating to any entrants is collected on behalf of or passed onto any social media.
- 21. Employees (and their families) of the Promoter, its associated companies, its retailers and agencies are not eligible for entry.
- 22. By entering the Competition, all entrants will be deemed to have accepted and be bound by these Terms and Conditions and by any other requirements set out in the information about the Competition.
- 23. These Terms and Conditions shall be governed by English Law and the parties submit to the exclusive jurisdiction of the English courts.
